Planning Appeal

Land North West Of 66 Over Norton Road, Chipping Norton

2 letters had been received for the Town Council to note regarding 2 planning appeals relating to: **Original planning application reference 21/00801/FUL Enforcement Notice 2021/2** (20/00037/PENF)

It appears to the Council that the above breach of planning control has occurred within the last four years. The siting of four caravans together with the engineering operations and construction of an access track and hard standing on a highly visible and elevated sensitive rural site located between the town of Chipping Norton and the village of Over Norton results in a harmful visual coalescence between the two settlements which appears extremely unsympathetic and incongruous within the rural landscape.
