No objection, although Clirs had gueries about the design and materiality of the flats. Residents have expressed a desire for a sustainable, 0 carbon development built to passivhaus standards, and Cllrs queried if more could be done to build the houses to this standard. Cllrs also noticed that the layout of the flats show the bin storage and mobility scooter areas located far away from the flats, which could pose a problem for those with mobility issues. The wording in the Design and Access statement notes that the flats will be for "affordable housing" and social rents, but that it would be useful to have more clarity about these terms.

Additionally, Cllrs hoped that the paved areas would be porous and permeable.
